

# Puppy Sale Contract and Agreement

## **Terms and conditions of contract:**

1. Buyer must have puppy examined by a licensed veterinarian within 72 hours of taking possession of puppy either via pickup or delivery. Seller must be informed immediately of the examination's results by email or by telephone. The failure to not comply with this term will result in the health warranty being null and void.
2. Buyer must provide puppy with routine preventative care such as, but not limited to: Annual veterinary examinations, appropriate vaccinations, heartworm and parasite prevention.

3. Buyer agrees that puppy will be provided with a healthy diet, fresh water, and will \*at all times\* be kept as an indoor pet.
4. Puppy must be paid in full prior to or at pickup. If puppy is being shipped, puppy must be paid in full prior to shipping.
5. All deposits are non-refundable. If Buyer does not take possession of puppy by 10 weeks of age, any and all monies paid will be forfeited to Seller and Seller shall make the puppy available to other buyers, unless special arrangements are made between Buyer and Seller and noted below.
6. Puppy has been examined by a licensed veterinarian and declared healthy and fit for sale. All appropriate vaccines and deworming have been received and records provided to Buyer.
7. This puppy is guaranteed until 1 year of age against fatal or life altering congenital disease which adversely affects the life of the puppy. This includes kidney, heart, pancreas, spine, and liver diseases of a severe or life altering nature. If the puppy dies within this one-year time frame, Buyer will pay to have a necropsy performed to determine cause of death. If cause of death is congenital, the seller will replace puppy.
8. This guarantee does not cover typical bulldog afflictions such as skin allergies, elongated soft palate, and stenotic nares.
9. This guarantee does not cover coccidia, giardia or bordatella, as all are very contagious and easily transmitted when shipping, traveling, going to the vet, dog parks, pet stores, etc.
10. This guarantee does not cover hip dysplasia as environmental factors contribute as much as, or more so, than genetic factors as to whether or not a puppy develops hip dysplasia. As such, it is important that the Buyer follow the recommended protocol of no structured exercise until after the growth plates close around 18 months of age.
11. All items covered by this guarantee are by replacement only. We do not give refunds.
12. Seller will NOT be responsible for any medical expenses incurred. Buyer is aware that owning a puppy requires appropriate veterinary care on a regular basis and that Buyer is responsible for all payments.
13. A puppy diagnosed with any serious congenital or genetic defect will be replaced as follows:
  - a. Puppy must be diagnosed by 1 year of age. Seller must be notified of the problem within 2 business days of the diagnosis by a licensed veterinarian's determination. A second opinion from a second licensed veterinarian, unaffiliated with the first, will be required to confirm the diagnosis. Seller will then provide a replacement puppy from the next available litter.
  - b. The puppy with a defect must be returned to seller, humanely euthanized by a licensed veterinarian (after discussing with Seller and with proof provided to Seller)—if puppy is euthanized without consulting with Seller, there will be no replacement provided.
  - c. Buyer may choose to spay or neuter affected puppy and keep it. If Buyer chooses this option, they may select a puppy from a future litter at a 50% discount.
  - d. No refund, in part or in full, will be given.

- e. A returned puppy must be returned to the Seller in good condition, other than the specified problem, at the Buyer's expense. Once puppy is returned OR proof of euthanasia is provided to Seller, the Buyer will be eligible for a replacement puppy.
- f. Buyer is responsible for any and all transportation costs associated with the replacement puppy.
- g. This guarantee applies ONLY to the original Buyer as stated in the contract, and is not transferrable to a second party.

14. Buyer agrees that if he/she can no longer properly keep and care for the puppy, the Seller shall have first right of refusal to reclaim the puppy at no cost to Seller. Any transportation costs would be the responsibility of the Seller and puppy is required to be returned in good health with AKC registration certificate signed over to Seller, as well as with all veterinary records and any other pertinent documentation.
